I'm starting to mobilize the credit/rating review for JEA under the new criteria format. I'm hoping to complete the review in November.

Please see the attached pdf with your MWh sales data, which is directly fed to us from EIA. The sales data is used to build our stress in the FAST tool. Please take a look at the annual data (especially the retail sales) and let me know if there are any egregious differences in any years, and what the actual sales should be for those years. We'd like to ensure the data is correct because the FAST utilizes a stress on future sales, based on variations in historical sales.

After the EIA data is verified, I can build a preliminary FAST. For this I'll need your most recent pro forma financials (including FY 2019) and capital plan. I'll send you a copy of the FAST once completed for us to review together. We've found the back-and-forth is helpful for you to understand how it works and for us to get the most complete/accurate view of your expected five year forward look, on which the stress will be applied.

Of course if you have questions during this initial process, please give me a call. But, I suspect we'll be in contact fairly often throughout this initial review under the new framework.
