Current situation is unsustainable for JEA – must do what is necessary to protect ratepayers.

Believe there can be a win/win (acknowledge this is an overused phrase but it accurately describes what we are working toward) that allows the project to move forward and serve the consumers for whom it is a benefit.

Believe protecting the remaining nuclear project under construction must be a priority to Secretary Perry because of FPA section 202 and we want to figure out a way to both protect our utility (8th largest in the US) while allowing the construction of Vogtle to continue.

Contemplated several doomsday scenarios but we want to suggest some alternatives for Brian's consideration that may be more palatable – use your example of paying a small amount to protect a project valued at multiples more

If Brian is cavalier or negative, consider telling him that our doomsday scenario includes multiple aggressive, assertive and proactive actions, taken simultaneously, that would likely result in great harm to the project. This is NOT what we, at JEA, want. That's why we are here and we very much want to try to work with DOE to find a solution that works.
