JEA - Plant Vogtle PR Messaging Document

Overview

- JEA entered into a purchase power agreement (PPA) with MEAG Power in 2008 as a means to diversify fuel sources and maintain price competitiveness for JEA's ratepayers.
- In exchange, JEA customers would receive power from the units once they were completed after the expected completion dates of April 2016 for Unit 3 and April 2017 for Unit 4.
- The Plant Vogtle expansion is the only remaining nuclear power plant construction project that is in active development in the United States. All other projects in recent years have been shut down for a variety of reasons, including economic infeasibility.

Project History

- The project was initially expected to cost \$9.5 billion in direct costs (\$14.8 billion total after including indirect and financing costs).
- The total cost of the portion attributed to JEA was \$1.4 billion. This amount was not expected to change over the course of the project.
- The project's initial general contractor, Westinghouse, declared bankruptcy in March 2017, which led to the project owners entering into an amended agreement with a new contractor, Bechtel, in June 2017.
- The new agreement, which was implemented without JEA's approval, is an unlimited cost-plus reimbursement arrangement, which means JEA's liability is no longer capped at a fixed amount.

Current Project Status

- As of August 2018, the project has experienced years' worth of delays and exorbitant cost increases.
 - The total cost-to-completion estimates have increased to more than \$30 billion, with no guarantees that amount will not rise again.
 - The estimated completion dates have been delayed to November 2021 for Unit 3 and November 2022 for Unit 4.
- JEA's liability has increased to more than \$2.9 billion an amount that is uncapped and subject to additional increases in the future.

Impact on Ratepayers

 Ratepayers in Georgia and northeast Florida are footing the bill for a project that continues to suffer from ballooning costs and delays. • All parties involved in the project have a responsibility to protect ratepayers' interests by cancelling the project's construction.

JEA's Judicial Declaration Claim

- On Tuesday, Sept. 11, 2018, JEA and the City of Jacksonville filed a complaint in the Fourth Judicial Circuit Court of Florida for declaratory judgment on the PPA.
 - The suit seeks to have the PPA declared "ultra vires," or in other words, a void agreement that JEA did not have the authority to accept.
 - The reason for this is that the PPA was never approved by the Jacksonville City Council, which is a requirement the Florida Constitutional law.
- If the court renders a favorable decision for JEA, the result will protect JEA ratepayers from having to shoulder the financial burden of paying increased rates to continue funding the rising uncapped costs of the Plant Vogtle expansion.

MEAG Power's Breach of Contract Lawsuit

• On the same day JEA filed its claim, MEAG Power filed a breach of contract lawsuit against JEA in the Federal Court for the Northern District of Georgia.

DRAFT PRESS RELEASE

Early today, JEA (f/k/a the Jacksonville Electric Authority) filed a Petition for Declaratory Order with the Federal Energy Regulatory Commission. In that Petition, JEA requested that the Commission declare that the Amended And Restated Power Purchase Agreement ("PPA") between JEA and the Municipal Electric Authority of Georgia ("MEAG") involves the interstate sale of electricity for resale, and as such is subject to the Commission's jurisdiction under the Federal Power Act ("FPA").

The transactions contemplated under the PPA involve the sale at wholesale in interstate commerce by MEAG to JEA of electricity and other services associated with incremental generation that is under construction at the Plant Vogtle nuclear generation facility in Georgia. Because the PPA involves the sale for resale of electricity in interstate commerce, it is subject to the Commission's jurisdiction under Section 201(b) of the FPA.

JEA's Petition expressly acknowledges that both JEA and MEAG are public entities that generally are exempt from regulation by the Commission pursuant to Section 201(f) of the FPA. But that exemption applies only to activities which are intrastate in nature, and not to the interstate sale for resale of electricity that is envisioned under the PPA.

JEA is not seeking any finding that the FPA applies to any other public entity, or that any transaction other than this specific PPA falls within the scope of the FPA. The Petition does not seek a blanket declaration of jurisdiction on any other PPA or wholesale sale of electricity transaction between any other public entities or any other party. Instead, JEA's Petition is expressly tailored to the specific facts and unique circumstances associated with the PPA.

Plant Vogtle Will Cost You

Dear Ratepayers and Concerned Citizens in Georgia:

The Plant Vogtle nuclear expansion project is a mistake that will cost you and your children for years to come. Act now to stop this historic misuse of your money.

The expansion of Plant Vogtle is one of the most expensive and mismanaged construction projects in history. The project was originally expected to cost \$14.5 billion for the construction of two new units. The first, Unit 3, was to enter service in April 2016 and the second, Unit 4, was to enter service in April 2017.

Since then, JEA's cost-to-completion estimate for the project has ballooned to more than \$30 billion with the completion dates delayed to November 2021 for Unit 3 and November 2022 for Unit 4. To make matters worse, these estimates are not guaranteed; and if the past is any guide, the cost will continue to rise.

As a ratepayer in Georgia, you will foot most of the bill for this endless project in the form of higher utility bills.

As power utilities owned by the public, the Municipal Electric Authority of Georgia (MEAG Power) and JEA (the municipal utility of Jacksonville, Florida) are uniquely positioned among the Plant Vogtle project participants. We have a collective duty to make decisions that are purely in the best interest of the customers we serve and not for shareholder returns. Our focus is on delivering reliable and affordable essential services to customers like you.

To protect our customers, JEA has proactively spoken out and acted to stop construction of the Plant Vogtle project. As a similar public power utility, it is time for MEAG Power to do the same. Alternative power that could realize savings of at least \$2.5 billion over the next 20 years for MEAG, PowerSouth and JEA ratepayers is available today. This alternative power does not use unproven technology like the Plant Vogtle project does and is generated from a plant that is already in operation so there is no construction risk.

Make your voice heard by contacting your local legislators, the Georgia Public Service Commission, and your MEAG Power representatives. Tell them to choose affordability, choose to protect the public, and choose to sav NO to Plant Vogtle.

There are two primary reasons why Vogtle is so over budget. The first is that all nuclear projects which must meet nuclear quality standards are always expensive. Because so few have been constructed in this country over the past decades, each construction project is unique. Unlike manufacturing an automobile or even a large commercial office building. there is no template. Each project is a customed project which takes many years to complete. The cost of materials and labors often changes as the project progresses and regulatory requirements can also change along the way. In the case of Project Vogtle, the original contractor went bankrupt and the ownership group - of which IEA is not a part chose a new contractor and entered into a contract that did not can the cost of the construction, thereby leaving every participant, including IEA, exposed. Remember, in the case of a nuclear plant, every component, every weld, every concrete pour is performed to exacting standards and is inspected. Nuclear plants are among the most complicated and advanced systems built by man. Second, Vogtle is expensive because it is the first project of its kind using a new NRC licensing program in an environment where the nuclear construction industry had largely disappeared. As other nuclear projects were canceled, more design costs were transferred to Vogtle. These are just some of the reasons IEA, as a nonowner but with all of the financial obligations of an owner, opposes the financial decisions being made to move forward with this bloated, delayed project when alternative power at a greatly reduced price is available. To stand by and go along in the face of the facts is an irresponsible way to represent IEA's ratepayers.

Deleted: The Vogtle project was largely protected by the Engineer, Procure and Construct (EPC) contract with the Westinghouse/Shaw Consortium. The EPC contract guaranteed a price for the plant (with some exceptions, like change in law and owners costs). Any cost overruns under the EPC contract were the responsibility of the consortium. Until Westinghouse, by then the only member of the consortium, declared bankruptcy, and paid the guaranty amount rather than be responsible for future cost overruns. Now the Vogtle construction is being performed under a cost plus fixed fee contract, with no limit.
